Release & Waiver of Liability, Assumption of Risk, Indemnity Agreement & Parental Consent

In consideration of myself and/or my minor child being permitted to participate in any way in the event(s) and/or being permitted to enter for any purpose any restricted area, defined to be any area which requires special authorization, credentials or permission to enter, I agree for myself and/or the minor;

1. I and/or the minor assume all responsibility and liability for all acts or activities of myself, my family, and crew and all damage that may occur as a result of my and/or the minor's participation in any GSMCA event.
2. I and/or the minor know the nature of the events and my and/or the minor's experience and capabilities, and believe myself and or the minor to be qualified to participate in the events. If I and/or the minor believe anything to be unsafe, I and/or the minor will immediately leave the restricted area and refuse to participate further in the event.
3. I fully understand and will instruct the minor that: (a) the activities of the events are dangerous and participation in the event and restricted areas involves risk and danger of serious bodily injury, including permanent disability and possible death; (b) these risks and dangers may be caused by my or my minors own actions, or by those of others who may be participating in the event, the rules, the condition & layout of the premises and equipment, or the releases named below; (c) there may be other risks not known to me or that are readily foreseeable at this time; (d) the social and economic loss and/or damages that could result from those risks could be severe and life altering, and could permanently change the minor's future.

I consent to my and/or the minor's participation in the event and/or entry into restricted areas and hereby accept and assume all such risks, known and unknown, and assume all responsibility for the losses, costs and/or damages following such injury, disability, or death, even if caused in whole or in part, by the negligence of the releasees named below.
